# 3. Hazards Identification of the Preparation:

# **Hazards identification:**

Xi: Irritant

# Particular information pertaining to risk for human and environment:

R10: Flammable

This product easily catches fire if it's exposed to an ignition source.

# 4. First Aid Measures:

#### General:

Immediately remove all contaminated clothing. In all causes of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

#### Skin contact

Remove contaminated clothing. Wash skin thoroughly with soap and water or use recognized skin cleaner. DO NOT use solvents or thinners!

### Eye contact:

Irrigate copiously with clean fresh water for at least 10 minutes holding the eyelids open. Seek medical advice. **Swallowing**:

# **HANDLING**

# Information for safe handling:

The product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Electric equipment should be protected to the appropriate standard. Preparation may charge electrostatically. Always use grounding leads when transferring from one container to another. Operators should wear antistatic footwear and clothing. Floors should be of the conduction type. Isolate from sources of heat, sparks, and open flame. No sparking tools should be used. Avoid contact with skin and eyes. Avoid contact and inhalation of the vapors and spray mist. Do not eat, drink, or smoke while working. Keep containers closed tightly. Never use pressure to empty (container is not a pressure vessel). Comply with the health and safety at work laws.

# Information about protection against explosion and fire:

# Storeroom and container requirements:

Although the storage and use of this product is not subject to specific statutory requirements, observation of the principles of the Highly Flammable Liquids and Liquefied Petroleum Gases Regulations are appropriate. It will be seen as good industrial practice in meeting the general duties of the Health and Safety at Work Act.

#### Further storage information:

Observe label precaution: Store between 5°C and 25°C in dry, well-ventilated place away from source of ignition. Keep away from oxidizing agents, strongly alkaline, and strongly acidic materials. Do not smoke. Prevent unauthorized access. Containers which are opened must carefully be resealed and kept upright to prevent leakage.
