# 4. FIRST AID MEASURES

**EYES:** In case of contact, immediately flush eyes with plenty of water for at least 15 minutes, check for and remove contact lenses. Seek immediate medical attention.

### **6. ACCIDENTAL RELEASE MEASURES**


