4. FIRST AID MEASURES

EYES: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes, check for and remove contact lenses. Seek immediate medical attention.

SKIN: Remove contaminated clothing. Immediately flush exposed area with large amounts of water. If symptoms persist, seek medical attention. Wash clothing separately and clean shoes before reuse.

INGESTION: Seek immediate medical attention, contact physician or poison control center. Do NOT induce vomiting unless directed to do so by medical professional. Never give anything by mouth to an unconscious person.

5. FIRE FIGHTING MEASURES

SUITABLE EXTINGUISHING MEDIA: Carbon Dioxide, Dry Chemical, Alcohol-resistant Foam. Do not use water, material will float and may ignite on surface of water.

FIRE FIGHTING PROCEDURES: Fight as volatile liquid fire Wear self-contained breathing apparatus pressuredemand (MSHA/NIOSH approved or equivalent) and full protective gear. Eliminate all sources of ignition. Evacuate unnecessary personnel. Use water spray to cool containers with caution, avoid spreading burning liquid. Water runoff can cause environmental damage. 6. ACCIDENTAL RELEASE MEASURES

ENVIRONMENTAL PRECAUTIONS: Avoid runoff and contact with soil, drains, sewers and waterways. Contact appropriate authority is spill is in excess of reportable quantity.

PERSONAL PRECAUTIONS: Eliminate all ignition sources. No smoking, do not use flares. Contact emergency personnel. Evacuate the spill area and keep unnecessary, unprotected personnel away. Always open containers slowly to allow any excess pressure to vent. Containers should be grounded when pouring. Take precautionary measures against static discharge. When transferring, follow proper grounding procedures. Use spark-proof tools and explosion proof equipment.
